2. Teachers with a master degree are placed on the TMA schedule. Teachers with a master degree who were on Career Ladder Level 2 with the District are placed on TMA L2. Teachers with a master degree who were on Career Ladder Level 3 with the District are placed on TMA L3.
3. Teachers with a doctoral degree on the TMA schedule will be paid an additional \$1,000 stipend above the TMA schedule.
4. An employee on the TBA schedule who has obtained a doctoral degree (or equivalent) will be eligible to receive the \$1,000 master degree stipend plus the \$1,000 doctoral degree stipend.
5. Salaries are rounded to the nearest dollar.
