1. Teachers with a bachelor degree are placed on the TBAM schedule. Teachers with a bachelor degree who were on Career Ladder Level 2 with the District are placed on TBAM L2. Teachers with a bachelor degree who were on Career Ladder Level 3 with the district are placed on TBAM L3.
2. Teachers with a master degree are placed on the TMAM schedule. Teachers with a master degree who were on Career Ladder Level 2 with the District are placed on TMAM L2. Teachers with a master degree who were on Career Ladder Level 3 with the District are placed on TMAM L3.
3. Teachers with a doctoral degree on the TMAM schedule will be paid an additional \$1,000 stipend above the TMAM schedule.
4. An employee on the TBAM schedule who has obtained a doctoral degree (or equivalent) will be eligible to receive the \$1,000 master degree stipend plus the \$1,000 doctoral degree stipend.
5. Salaries are rounded to the nearest dollar.
