SUMMARY: On March 15, 2016, the Board voted to notify the Commissioner of its intention to vote on the Local Innovation Plan drafted by the Local Innovation Committee appointed by the Board on January 19, 2016. After receiving the proposed plan, the Texas Education Agency contacted the District and suggested the Local Innovation Committee consider revising the plan to include additional references to specific provisions of the Texas Education Code. Based on the input received from TEA, the Local Innovation Committee has revised the plan to include additional references to specific laws relating to teacher certification and educator appraisals. This revised final plan has been posted on the District's Internet website. Prior to voting to adopt the proposed plan: (1) the final version of the proposed plan must have been available on the District's Internet website for at least 30 days; (2) the District-wide Educational Improvement Council (DEIC) must have held a public meeting to consider the final version of the proposed plan; and (3) the DEIC must have approved the proposed plan at its regular meeting on May 17, 2016.
