Advanced Placement Student Expectations & Agreement

A variety of Advanced Placement courses are offered at FRANKLIN HIGH SCHOOL to provide all aspiring students an opportunity to become college ready. The varied course offerings are aimed at encouraging students of diverse backgrounds to achieve their potential through college level coursework. Specifically, our aim is to prepare students for a future that they may not have otherwise considered or have had the opportunity to pursue.

Due to the inherent rigor of Advanced Placement courses, it is imperative that students remain actively engaged in coursework throughout the year. Moreover, it is the expectation of FRANKLIN HIGH SCHOOL that **ALL STUDENTS** enrolled in an AP Course be expected to take either this respective AP Exam in May. In addition, attendance at any review sessions for their AP courses is **MANDATORY** unless students obtain prior approval for their absence by the instructor.

Registration for the AP Exams will take place from September through October. While the customary cost of the AP Exam is approximately \$95, FRANKLIN HIGH SCHOOL has chosen to support AP students by supplementing a portion of the cost of their exam. Consequently, the cost for each AP Exam will be \$15 for each exam ordered. **Students must pay their registration fee with the campus business office/online prior to OCTOBER 30, 2020.** ONLINE PAYMENT INSTRUCTIONS WILL BE GIVEN PRIOR TO SEPTEMBER 1. Exams ordered after November 13, 2020, will be charged a late fee of \$40. SECOND SEMESTER COURSE HAVE A DIFFERENT DEADLINE OF MARCH 5, 2021. (MACRO ECON, US GOVT AND PSYCH AP TAKEN 2ND SEMESTER)

ACADEMIC DISHONESTY: All students are expected to put forth their best effort on all assignments and more importantly, produce their own work. Students that submit someone else’s work as their own, attempt to access unauthorized resources, assist other students without permission, or allow others to violate the academic dishonesty policy will be in violation of the policy and subject to disciplinary measures including but not limited to receiving a zero on the assignment and/or an administrative referral.
