2018-19 Student Parking Policy for Coronado High School

T-Bird Family,

It is an exciting time for our Coronado community as we move forward with the reconstruction of our school. The project includes 2 new parking lots for students. There will be necessary inconveniences as we work toward completion of this project. **Student parking will be very limited until the new lots are completed by the end of the first semester**. The new lots will be located behind the stadium and by the softball field next to Cloudview Park. When these lots are finished students should have over 200 more spots than last school year to park.

All students will be able to apply for a parking permit when registration begins. Please read the policy below for the criteria necessary to be issued a permit.

The following criteria will be used to issue a Coronado HS parking permit to a student:

- 1) The student must be currently registered in the school TEAMS system.
- 2) Only 1 parking permit will be issued per family.
- 3) The vehicle must have a valid license plate and the student a valid driver's license.
- 4) Students must provide proof of insurance.

Guidelines for students who are issued a permit:

- 1) Student must obtain a parking pass on a "first come/first serve" basis from the designated Assistant Principal.
- 2) Adhere parking permit behind the rear view mirror in top center of the windshield.
- 3) Vehicles are parked on the campus at the owner's risk.
- 4) Students must only park in the designated lots/parking spaces assigned to them.

There are now 5 parking lots designated for students for 2018-19:

-Stadium/Fine Arts -Ag/FFA -Tennis Court/Baseball -Behind the Stadium -Softball/Cloudview Park

Faculty will park in the old "Senior Parking" across the street from marque and in front of D building.

Violations which may result in consequences but are not limited to:

- 1) Parking in an illegal area (handicap, fire lane, designated faculty or lined no parking)
- 2) Parking without a permit adhered to the wind shield.
- 3) Parking without a valid license plate on the vehicle.
- 4) Inappropriate or dangerous driving anywhere in the vicinity of the campus.

Parking is a student privilege which may be revoked

Possible Consequences:

- 1) Student receives warning from school administration and parents contacted.
- 2) Parking citation issued by EPISD police for a vehicle being illegally parked.
- 3) Revocation of the parking pass for repeated violations.
- 4) The vehicle towed at owner's expense for serious and/or repeated violations.
