FOR CAMPUS PERSONNEL AND STUDENTS

CAMPUS PERSONNEL

TUESDAY - SEPTEMBER 8

Identified Fall Sports Coaches, Fine Arts Teachers, JROTC Instructors and *Participating Students Return to Campus*

MONDAY - SEPTEMBER 21

Identified CTE Teachers that instruct the following: Culinary Arts, HST/EMT, Diesel Tech, Electrical Tech and Automotive will return to Face to Face Instruction on campus to fulfill hours required for students to receive Dual Credit per EPCC

MONDAY - SEPTEMBER 28

Campus Administrators, Counselors, Nurses, Clerical Staff, Paraprofessionals, Campus Patrol, Parent/Military Liaisons, Diagnosticians, Speech Therapists, Reading Specialists Librarians, ALLs, Campus Teaching Coaches will return to Buildings for Safety Training and work space setup

Identified Teachers return to Buildings for Safety Training and Classroom Setup to serve (Group D). Virtual Instruction is facilitated from campus until students return.

WEDNESDAY - SEPTEMBER 30

ALL EPISD 6th grade and 9th grade Teachers, including all elective teachers, fine arts teachers and PE coaches return to buildings for Safety Training and Classroom Setup to serve Groups A/B, Group C and Group D.

WEDNESDAY - OCTOBER 7

ALL remaining EPISD employees return to buildings for safety training and classroom setup. Virtual, phase 1 and phase 2 instruction are facilitated for all groups from campuses.

MONDAY - OCTOBER 12 TO OCTOBER 16 EPISD INTERCESSION

MONDAY - OCTOBER 19 FORWARD

Starting with students in Pre-K through 8th grade, students may return to campuses face-to-face 5 days a week
Starting with High School students, Grades 9-12 may return to campus through a staggered schedule (Group A/B and Group D - Special Education students)
Parents may continue to opt into Group C - 100% Virtual School, 5 days a week

TUESDAY - SEPTEMBER 8

Identified student groups for Fall Sports, Fine Arts, JROTC Instructors and Participating Students Return to Campus

MONDAY - SEPTEMBER 21

Identified CTE Students will return to Face to Face Instruction in order to fulfill hours required to receive Dual Credit per EPCC

THURSDAY - OCTOBER 1 AND FRIDAY OCTOBER 2

**Phase 1 - Identified Student Populations begin to Return to Campus (Group D) for face-to-face Instruction 5 days a week:*

SLC, CRC, BIC, AIM, ECSE, RDSPD, Pre-K, K, 1st grade & 2nd grade

MONDAY - OCTOBER 5, THROUGH FRIDAY OCTOBER 9

**Phase 2 - Identified Student Grade Levels from Middle School and High School Return to Campus for Transition Monday through Friday*

**Identified 6th Grade Students only for Middle School face-to-face 5 days*

**9th Grade Students Group A/B & D for High School - Hybrid/Staggered to maintain the 40% waiver 9-12th grade Students return based on last name & designated days
Example: Mondays and Tuesdays (A-L)
Wednesday - Asynchronous @Home & Deep Clean
Thursdays and Fridays (M - Z)*

MONDAY - OCTOBER 12 TO OCTOBER 16 EPISD INTERCESSION

MONDAY - OCTOBER 19 FORWARD

Starting with students in Pre-K through 8th grade, students may return to campuses face-to-face 5 days a week
Starting with High School students, Grades 9-12 may return to campus through a staggered schedule (Group A/B and Group D - Special Education students)
Parents may continue to opt into Group C - 100% Virtual School, 5 days a week
