SECTION I: School Information

In 2014, El Paso Independent School District and El Paso Community College jointly created Burges Early College High School. This unique school, first in the El Paso area, is specifically designed to provide students the opportunity to begin college during the ninth grade. This program enables students to progress in four years from the ninth grade through the first two years of college earning both their HB5 high school diploma and an Associate of Arts (A.A.) in Multidisciplinary Studies from EL Paso Community College.

Students are a part of the Burges family, able to participate in high school activities and extra-curricular programs throughout their four years in high school. Under this model, BECHS provides dual credit at no cost to students; offers rigorous instruction and accelerated courses; provides academic and social support services to help students succeed; increases college readiness; and reduces barriers to college access.

Our commitment to our Burges community is that we prepare, nurture, and guide our students to achieve excellence in all areas. We have created a great partnership between El Paso Community College and the University of Texas at El Paso. This partnership will remove any perceived educational obstacles for our students in their personal goals and dedication to earn an associate degree, Bachelor's degree, and beyond.

SECTION II: Applicant Criteria, Expectations, and Selection Process

The criteria for selecting and retaining students into the Burges Early College High School are as follows:

- Applicant must meet all requirements for promotion from 8th grade to 9th grade.
- Applicant must submit an online admissions application/hard copy admissions application by the deadline of November 30, 2023. Out-of-district students must submit a copy of their 7th grade transcript and current 8th grade progress report. Failure to submit transcripts and/or progress report by the deadline will not be considered.
- ALL applicants MUST ATTEND a two-week Summer Bridge program in June of 2023.
- Students must prep and meet passing on the Texas Success Initiative Assessment 2.0 (TSIA) prior to the Spring semester of their freshman year.

Expectations for student participation in Burges Early College High School:

- Students participating in BECHS will adhere to all rules and regulations for both Burges High School and El Paso Community College. This includes, but not limited to:
 - 1. Attendance
 - 2. Discipline
 - 3. Grades
 - 4. Tardiness
 - 5. Mandatory tutoring
- Students can be removed from Burges Early College for not making academic progress or for disciplinary issues. Academic removals occur only after multiple course failures or academic suspension. Review of academic status will be conducted by BECHS administration and teachers.





Selection process for Burges Early College High School:

- There are only 135 seats in the Burges Early College High School program.
- If there are more than 135 applicants, a lottery system will be used to select 135 students for the incoming cohort. Students that are not selected will be placed on a waiting list.

- OUT-OF-DISTRICT STUDENTS ONLY: Must submit BECHS Admissions Application and a copy of their 7th grade transcript and current 8th grade progress report. (Applicants who wish to submit an online application may email their transcripts to <u>cmestra1@episd.org</u>).
